#### Notes

- 1. The nominal external height of the C3 portal is increased by 30 mm and the C190 portal is increased by 70 mm when surface-mounted.
- 2. The portals are supplied with a number of standard features such as LED lights within the ceiling. Certification does not cover the use of other optional design features or accessories that are not listed. Utilisation of other accessories may affect the level of security offered by the portals.
- 3. The emergency release system is deadlocked by a key. Although outside the scope of LPS 1175, special consideration should be paid to the use of an emergency release system with a separate deadlock.
- 4. The portal is configured as 'fail secure'. The resistance of the access control system to "non-mechanical" attack has not been assessed as it is outside the scope of LPS 1175. Likewise, the approval does not cover possible effects of any susceptibilities relating to the functionality and performance of any access control equipment that may be used to operate these locking systems. This is because the scope of access control devices and system configurations that may be used with these locking systems is "infinite". It is therefore recommended that specifiers and installers satisfy themselves that the components are either resistant to mechanical and other forms of tampering/abuse, or that they are suitably protected from such tampering/abuse and are resistant to any environmental conditions/interference that may cause the locking system to disengage.
- 5. The portals are approved for installation into existing structures offering equivalent resistance to physical attack as the portals in accordance with the instructions contained on the documents titled 'Portal C190 MY18 Mechanical Assembly Manual' Release 1.0 and 'Portal C3K WK4 4 Wings Mechanical Assembly Manual' Release 1.0.
